WHO WE ARE

TeamChild is a nationally recognized nonprofit serving vulnerable youth across Washington State. TeamChild is best known for its legal services program reaching children in crisis in King, Pierce, Spokane, and Yakima counties. Our clients are generally 12-24 years old and many are involved in the juvenile justice and child welfare systems. Our legal services program is designed to keep young people out of juvenile court by reconnecting them to education, healthcare, and housing supports. We work closely with public defenders, juvenile court staff and the community to positively impact the young person's life while helping the youth to accomplish their goals and reduce further contact with the courts. The mission of TeamChild is to uphold the rights of youth involved, or at risk of involvement, in the juvenile justice system to help them secure the education, healthcare, housing and other support they need to achieve positive outcomes in their lives. In our work, we aim to move systems away from exclusion, arrest, and incarceration towards more effective strategies that have the best chance of promoting the well-being and success of our most vulnerable children.

At TeamChild we believe that racial and other social identities should be respected and affirmed. In support of this belief, we are trying to build an equitable and inclusive organization and providing our team of staff, volunteers, and Board members with the tools to address institutionalized racism and other forms of oppression. THE ROLE

TeamChild's Policy Team is excited to offer a 10-week, 10 hours a week winter internship opportunity that starts in January 2024. This exceptional learning opportunity is open to undergraduate and law students. This position supports the work of our policy and legal services team, focusing on a special project to support individual youth and solve for system barriers when youth have no safe living situation upon release from a county detention facility.

Youth under the age of 18 are impacted by county juvenile detention confinement when they face barriers to successful release from detention, primarily due to lack of safe/stable housing placement. This project provides direct representation of youth, outreach and education to youth, families, community, defense attorneys, and court staff, development of legal written resources or workshops, and participation in stakeholder collaborations. We are also working to provide leadership and facilitation of youth, families, community-based providers, court professionals, housing advocates, state agencies, and other invested partners to identify statutory, regulatory, and resource barriers that impact youth releasing from detention. To support this work, the person in this position may be conducting research, statewide and nationally, collecting and analyzing data and trends, developing training materials, assisting in the development of progress reports, and supporting the individual case work along with the attorney assigned to each case.

QUALIFICATIONS

- Strong research and writing skills;
- Experience or interest in juvenile legal system reform, alternatives to incarceration, intersectionality with incarceration and youth experiencing housing instability;
- Commitment to Social Justice;
- Interest in working with youth and families of diverse racial, cultural and socioeconomic backgrounds;
- Able to work independently and self-motivated;
- Commitment to learning about and addressing racism at an individual, organizational and systems level.
